



Dear Member-Owner,

The bylaws of East County Schools Federal Credit Union (ECSFCU) state that when there are open positions on the Board of Directors, there will be an election and a ballot sent to all members of record. The volunteer Board of Directors govern ECSFCU, and as a credit union owner, you enjoy the right (one member, one vote) to vote representatives to the Board and thus participate in decisions affecting the future and direction of your credit union.

We encourage you, as a member-owner of East County Schools Federal Credit Union, to exercise your right to vote as you wish to be represented. This year, there are three open positions and five candidates running for the Board. You may vote for up to three (3) candidates.

Ways to Vote

For your convenience, you may choose to vote on the Internet, or via paper. You may choose only one (1) of the following options:

- **Internet:** Vote online using the link at www.eastcountyschools.org/vote. Simply go to the ECSFCU website and follow the instructions to place your vote. You will be directed to our provider, CU Ballot at <http://eastcountyschools.cuballot.com>. Please be sure to have your ECSFCU member number available.
- **Paper:** Vote via paper by filling out the ballot below and returning this page in the included postage paid envelope addressed to:
